- (i) "vendors" refers to business owners, sales representatives, brand ambassadors, brand representatives, team members, volunteers and/or persons occupying vendor tables.
- (ii) "event" refers to Vancouver Reggae Sunsplash Festival, Sat & Sun. July 12 & 13, 10 am -10 pm
- (iii) "venue" refers to Vancouver Art Gallery - North Plaza: 750 Hornby St, Vancouver
- (iv) "organizer" refers to Afro Nation Entertainment Society
1. a. The vendor recognizes that he/she takes part in the event willingly and in good faith
  - b. The vendor is responsible for all set-up and take-down of his/her business equipment including but not limited to signs, posters, merchandise, displays etc.
  - c. The vendor is responsible for the condition of any rented equipment and will return items in good condition and without damage.
